COVID-19:

During the COVID-19 pandemic, our school will try everything to avoid the virus. Please wear a mask and disposal gloves during the behind the wheel training. However, if you are infected during training or infected from other places, our school will not be liable.

During the pandemic, Only the instructor and the student may be present in the training vehicle (no other students are allowed). If requested, a parent may be present in the training vehicle, seated in the back seat.

Eligibility: I understand that, according to the state law: Section 1060.180, the student must satisfy the following and then can attend the teen course. (please find the required forms at our website).

- At least 15 years of age prior to the end of the classroom portion of the course.
- If the student is enrolled in school, he/she has received a passing grade in at least 8 courses during the 2 semesters.
- If a student who has dropped out of school and has not yet attained the age of 18 years, must satisfy one of the follows:
 - A) obtain written documentation verifying the dropout's enrollment in GED or an alternative education program or obtain a copy of the dropout's GED certificate;
 - B) obtain written verification that the student prior to dropping out, had received a passing grade in at least 8 courses during the 2 previous semesters last ending prior to requesting a certificate of completion; or
 - C) obtain written consent on a form prepared or approved by the Secretary of State from the dropout's parents or guardian and the regional superintendent.
- If a student is home schooled, he/she will obtain written verification on a form prepared or approved by the Secretary of State stating the student is enrolled in a home school;

In addition to the eligibility requirements, other terms include:

- The course includes 30 hours in classroom and 6 hours behind the wheel (BTW) in order to request the blue slip upon completion. The total cost is \$450. Student pays \$100 deposit at registration and pay the rest at the first class time.
- For BTW only, the cost is \$350. For classroom only, \$250.
- If fail to show up at a scheduled driving session, a \$50 fee will be charged before next scheduled driving session.

- According to Illinois State Law, a Minimum of 30 hours of classroom instruction is required (**the instructions will be online during the pandemic**). Any student absent for more than (4) class sessions will be dropped, and their permit will be rescinded. Students who are dropped will be required to reenroll and start the class over. Should re-enrollment be required, **the school will not refund any tuition or part of tuition if the school is capable and willing to perform its part of the contract**, and new charges will apply. Any absences of (4) or less must be made up during one of our upcoming classes, and any missed work must be completed. All canceled classes due to weather or unforeseen circumstances will be made up at a later date.

The instruction times are scheduled as follows:

- Driving Lessons—Each Driving Session last for a total of (2) Hours (**1.5 hour only during the pandemic**). Two students are required to drive each session (**only one student is allowed during the pandemic**). Each student will drive for (1) Hour and Observe for (1) Hour (**not required during the pandemic**). Students are required by Illinois State Law to complete a minimum of (6) Hours of Behind the Wheel Instruction, and (6) Hours of Observation (**not required during the pandemic**). (These Hours do not count toward the additional (50) Hours of Practice Driving required by Illinois State Law) Students are required to give (24) hours notice of cancellation. Students who fail to give proper notice of cancellation, will be subject to a \$50 fee. Students will not be allowed to drive until this fee has been paid.
- If this student is within 3 miles from our school, we will offer pickup and dropoff for free. Otherwise, we will charge the time on the road for the services (\$50/hour, or \$25/30 minutes) or you can drop off and pick up the student.
- Under the Influence – Students will be dropped from class if found to be under the influence of Alcohol, or any illegal substances during class or drive time. This is your only warning!! **The school will not refund any tuition or part of tuition if the school is capable and willing to perform its part of the contract.**
- I agree to pay all expenses resulting from any traffic violations I am responsible for, as well as any raise in my insurance rates as a result of these violations.
- The instructor will effectively and safely teaches the students. The training car has the highest insurance coverage from State Farm on Liability, Medical, Uninsured Motor Vehicle, and Underinsured Motor Vehicle as follows. If because of the student's fault, an accident happened, the insurance will have the following coverage and for the exceeded the coverage's expenses, the school will be not able to cover the exceeded expenses and the student will be responsible for it. If the school's car got damage because of the student's faults, the student will pay \$300.
- **The agreement constitutes the entire contract between the school and the student, and no verbal assurances or promises not contained in the agreement shall bind the school or the student.**
- **All disputes under this Section shall be directed to the Secretary of State's Office; and**
- **all students attending a full teenage accredited program to complete the entire course within 9 months from the date of the first classroom lesson.**
